

Spring 2024 Course Registration, Revenue and Applications
1 Week Before 1st Day of Instruction
January 9, 2024

The following is a brief, initial summary of spring semester enrollment activity as of Tuesday, January 9, 2024.

Figures have been normalized relative to the first day of instruction for spring term, however all information is considered preliminary at this time due to differences in the date spring term registration opened last year compared to the date for this year.

Priority registration for spring 2024 semester started more than one week earlier than for spring 2023. Open registration for spring 2024 semester started more than two weeks earlier than it did last year for spring 2023. As a result, course registration and revenue currently appear greater for spring 2024 than spring 2023, year-over-year. This effect will continue to stabilize as the first day of instruction approaches.

Note: Information is preliminary. Spring 2023 semester instruction began Tuesday January 17, 2023 and spring semester 2024 instruction will begin Tuesday January 16, 2024. Comparable dates relative to each university's weeks to start of instruction are reported, and if not available the closest comparable date is selected. Priority registration for spring 2024 semester started more than one week earlier than for spring 2023. Open registration for spring 2024 semester started more than two weeks earlier than it did last year for spring 2023. **As a result, course registration and revenue volume currently appears greater for spring 2024 than spring 2023, year-over-year. This effect will stabilize as the first day of instruction approaches.** Includes all for-credit course registration activity, regardless of a student's degree seeking status.
